PETITIONERS' RESPONSE TO RESPONDENT'S OBJECTIONS TO DEPOSITION UPON WRITTEN QUESTIONS OF SECRETARY OF STATE SAM S. REED

The deposition of Secretary of State Sam S. Reed and the exhibits thereto are relevant to the question of whether the State's paramount duty is to provide all Washington children with a substantive education, or whether that duty is satisfied by an amalgam of funding formulas. Secretary Reed's testimony and the documents he authenticates demonstrate why a substantive education is a necessary prerequisite for citizens to exercise their rights in our democracy.

Additionally, the testimony provides a foundation for determining whether the Respondent is providing all Washington children with the knowledge and skills necessary to participate in our State's democracy (part of determining whether the education is preparing students to meaningfully participate in our State's democracy is understanding what is actually required to meaningfully participate in that democracy).
