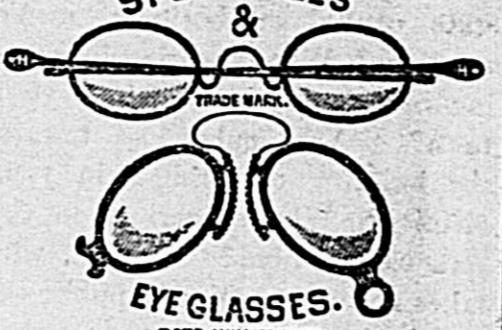

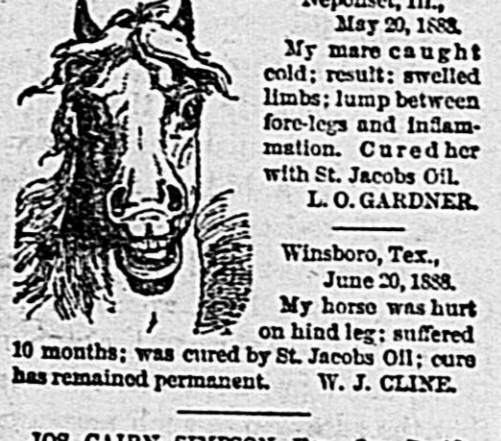
NOTICE.

NOTICE is hereby given that whereas judgment was rendered in the justice court of Lewis county, Washington Territory, by J. L. McKibben, justice of the peace for Klickitat Precinct, on the 17th day of August, 1889, in a suit wherein John O. Doss was plaintiff and Joseph Greenway and Frank Washburn as co-partners were defendants which said judgment was in favor of the plaintiff and against the defendants, and is for the sum of two hundred and ninety-nine 11-100 (\$299.11) dollars, and cost of suit. Now therefore the said Frank Washburn is required to be and appear before said justice of the peace at his office in said county and precinct near Mossy Rock postoffice on the 28th day of September, 1889, at the hour of 10 o'clock a. m. and show cause why said judgment should not be binding upon him and the said Frank Washburn, and be and remain in full force and effect. CIRCULAR.

To the Voters of Washington.
Be it resolved by the State Grange of Washington, that we are opposed to the constitutional convention that met at Olympia for the following reasons:
First. It provides for more offices than the public service requires, and it also makes provision for the creation of offices by the courts and legislature uncalled for and unnecessary.
Second. The salaries are fixed too high, with no provision for a reduction of the same, but in nearly every instance it provides for an increase.
Third. This being the case, the result will be an office-seeking class—the most worthless that can exist. It will also foster machine politics of the most corrupt and offensive character.
Fourth. It is calculated to encourage extravagance in the expense of the legislative assembly, and also in all its appropriations, and thus to grievously burden an overtaxed people.
Fifth. It provides for secret sessions of the legislature to which we are strongly opposed.
Sixth. It invites foreign capital to come here and obtain possession of our industries, and operate the same, and thus in time reducing our fair young state to the same condition that Ireland occupies today. We believe that our land, our industries, and our mines should be held sacred to American capital and to American industry.
Seventh. It provides that it shall take a two-third vote of both houses of the legislature to submit an amendment to the constitution to a vote of the people thus practically prohibiting any amendment thereto.
Eighth. For these and many other reasons, we call upon farmers', laboringmen and all taxpayers to unite with us in voting down an instrument fraught with so much peril to the public welfare.

Read This.

When the white miners of Roslyn were displaced by negroes last fall the territory was at a loss to account for the change, for which there was no apparent reason. The white men were law-abiding, had purchased their own homes from the company and were paying for them out of their slender earnings. Most of the men, we are informed had families to support, and were apparently fixtures in the community. They had just suffered a severe loss by fire, almost an overwhelming one for them, and yet they were not depressed but hopeful, courageous and industrious. It was then the killing blow fell. Five hundred ignorant negroes, without families were unexpectedly precipitated upon Roslyn, and the white men were told that they were not wanted. The amount of suffering entailed upon these men and their helpless families by this heartless edict will perhaps never be told, but it may be easily imagined. The cause for the change is now apparent. The owners of the mines are republicans and monopolists. They laid their plans away ahead. Washington Territory was soon to become a state. To control absolutely 500 votes was something they had to consider if they wished to retain their relentless grip on the commonwealth. The more ignorant men are, the more readily they can be ruled. But white men were not so easily controlled and were disposed to be independent factors when it came to exercising their vote, hence they were left out in the cold. Had the Chinaman been a voter it is reasonable to assume that he, and not the negro, would have been selected as a still more desirable tool. But the republican party has not as yet been able to bestow the power of suffrage upon the Mongolian, and hence he was ineligible for the purposes to which the 500 Roslyn miners were to be put. There is no doubt but that Roslyn will go republican—the bosses will see to that, but will the white laborers of the territory submit without a protest to the crime that was perpetrated there when industrious and sober white men with families to support, were thrown out of work by the importation from a distant negro labor. We have it from a trustworthy source that when this campaign is over a still further importation of negroes into the state, on a large scale, is to be brought about. Any one who may be in doubt as to the result of negro immigration on a large scale has only to visit Evansville, Indiana, to be informed. There are 15,000 negroes out of a population of 50,000, serve as an object lesson for the republican party.

Women Suffrage in the Constitution.

The impending election will mark an era in the history of our state. In the adoption of a constitution, a multitude of questions confront the voter and knock for solution, but among them all, there is none more important than that of recognizing in women an equal right with man to the elective franchise. Let me be understood in this connection. It makes me mad to hear some sap-headed man talk about "giving women the right to vote." God gave women the right to vote when He gave her the right to live. To deprive one-half of the adult citizens of Washington of the right to vote by constitutional provision would be under the circumstances, so gross an infraction of popular liberty, as to challenge at once profound regret and supreme indignation. Consider the situation for a moment, if you please: Possessing a legal right to vote under the laws of the territory and exercising that right for years, the women of Washington were recently deprived of that privilege by a decision of an imported judge, who exercised the judicial function, not by virtue of the suffrages of the people, but in consequence of a presidential appointment. That decision was based on grounds purely flimsy and technical, and if good law, would be good reason for disfranchising the women of Wyoming territory, who now have the right to vote and have exercised that right for twenty years.

Men of Washington, let me beg of you to remember that the right of one sex ought not to be the wrongs of the other. "Vox populi vox dei," the will of the people is the will of God, is an old saying but true as trite. The right of the people, that is the adult male and female citizens of Washington, to rule themselves is a divine prerogative and inheres in popular government. Women are citizens equally with men and "the right to vote inheres in citizenship and can be forfeited only by ignorance or crime." The decision of an imported judge at present, regulates our wives, mothers, sisters and daughters to the political condition of aliens, idiots, lunatics criminals and Indians, not taxed. Can it be possible that the men of Washington are so lacking in justice and magnanimity as to refuse to vote for the woman suffrage article in the constitution thus deliberately sanctioning and perpetuating this monstrous outrage? Again I say, consider the situation. The women of Washington have been deprived of the right to vote by the most monstrous and diabolical wrong; the men have formed a constitution without the advice or consent of the women and now proceed to submit the question of woman suffrage to the male voters of the territory. This is just as though women have no rights which men are bound to respect. To deprive them of the right to vote is to subject their lives, their liberties and property to the caprice of a male legislature. The injustice, incongruity and enormity of the present condition of things may be comprehended, if we men will consider how we would like it, if the women had met in convention, formed a constitution, guaranteeing in the main body thereof, the right of women to vote and very magnanimously submitting the question as to whether men should vote, to the adult women of the territory in a separate article. I believe with Lloyd Garrison, that "those who are ruled by law should have the power to say what the laws shall be and who the law makers; with William H. Seward, that justice is on the side of woman suffrage; with B. F. Wade, that every argument that can be adduced to prove, that males should have the right to vote is equally conclusive that females should have the same right; with Justice Chase, that there will be no end to the good that will come by woman suffrage; with George Hoar, that there is not a thoughtful opponent of woman suffrage to be found who is not obliged to deny

the doctrine which is affirmed in our Declaration of Independence.

In conclusion permit me to say that the qualified voters of Washington will have an opportunity of performing, on October 1st, the noblest and most important act of their lives. It is needless to say that I refer to the privilege of voting for woman suffrage. Vote for woman suffrage, and if anyone asks your reason for so doing, tell him you do so in the name of God and the Continental Congress.
