The grand jury of San Joaquin county has presented its final report of Deputy U. S. Marshal Nagle. It says that the facts show that the killing of the late Judge Terry was intentional and deliberate violation of the constitution, and Nagle should be tried thereunder. The accused was taken from the power of the state by a process eminating from the United States circuit court. The report continues: The United States circuit court has decided that Nagle cannot be tried by the Federal court, essentially for a like want of jurisdiction from which it is fair to conclude he cannot be tried in any court.
