## IVAN W. GOODNER

The Law School was shocked and saddened at the sudden death of Ivan W. Goodner on the morning of November 16, 1931. In his passing we as a school and as individuals have suffered a distinct loss.

Born in Illinois in 1858, Professor Goodner spent his early life in that state and Vermont, later going to Dakota territory. He received his law degree from the University of Nebraska in 1897 and from that time until 1907 practiced law in South Dakota. During part of that period he was a member of the State Board of Regents of Education and president of the Board for several years. He also served as state senator for a term. In 1907 he came to Seattle as senior member of the firm of Goodner and Goodner. Appointed as a lecturer in the Law School in 1910, he became a full professor in 1912 in which capacity he served until his death.

In his twenty years of devoted service to this Law School, he left a deep impress upon his colleagues and students. A true gentleman possessed of gracious geniality and wholesome friendliness, he combined high ideals with a sincere devotion to his duty and a real interest in those who came under his able instruction.
