EDITOR'S NOTES

Because the 1963 United States-Japanese Symposium was well received, the Washington Law Review established a new Editorial Board position and added the Asian Law Symposium as an annual publication. This Symposium will be published in August of each year in addition to the normal four issue coverage of the past.

This year, as in 1963, the Symposium is designed to aid practicing lawyers in transactions involving international trade with Japan. Professor Dan F. Henderson has been instrumental in making this issue possible by directing the efforts of all concerned. In addition, Professor Henderson has set forth the scope of this year's Symposium in an introductory article.

Looking prospectively, the 1965 Symposium will explore another field of Asian law, commercial transactions between the United States and the Phillippines. However, because of the increasing interest in the Japanese business and investment field, future years will see additional coverage of these areas with particular emphasis on U.S.-Japanese commercial law problems. Also, as the new nation of Malaysia establishes a position in the commercial world, Symposium treatment is contemplated.
