# STATE BAR ASSOCIATION NOTES

## REFERENDUM RESULTS

The Board of Governors has received returns on the postal card referendum mailed out to the lawyers of the state on or about November 28. The votes on the several proposals was as follows:

Proposal No. 1, recommending the abolishing of the office of constable.

Approve 866, disapprove 48

Proposal No. 2, favoring the whipping post in the following cases:

a. Crimes committed with force or violence with the threat or offer thereof or by the aid of or with the use of dangerous weapons.

Approve 514, disapprove 473

b. In all cases of persons convicted for a second time or more of felony.

Approve 414, disapprove 549

c. In cases of a conviction for a felony where a sentence of imprisonment is imposed or suspended.

Approve 288, disapprove 661

d. That such punishment be imposed only upon males whose physical condition will permit them to receive the punishment without substantial danger of permanent injury.

Approve 840, disapprove 148

Proposal No. 3. Recommending a constitutional amendment providing for a new code for Justice of the Peace Courts.

Approve 840, disapprove 148

Proposal No. 4. To permit the trial judge to comment upon the evidence.

a. In criminal cases only.

Approve 254, disapprove 575

b. In civil and criminal cases.

Approve 423, disapprove 525

c. To retain the present rule.

Approve 463, disapprove 361

Proposal No. 5. Recommending the adoption of a statute requiring that any new promise to pay a debt discharged by bankruptcy must be in writing.

Approve 845, disapprove 151
