Two New Governors

The Second and Fourth Congressional Districts Will Select New Board Members in June

Vacancies in the Board of Governors occur in the Second and Fourth Congressional Districts this year. George W. McCush of Bellingham, Second Congressional District, and D. V. Morthland of Yakima, Fourth Congressional District, have requested that it be announced that they will not be candidates for reelection from their districts.

Any active member of the Washington State Bar Association in these districts who obtains signatures of twenty active members in the district may have his name placed on the ballot. Nominating petitions for this purpose may be had at any time after May 1 by writing to the Executive Offices of the Bar Association, Dexter Horton Building, Seattle, or from the clerk of the court in the county in which you reside. When the necessary twenty signatures have been obtained, the nominating petition should be mailed to the Executive Offices prior to May 1. On June 1 ballots will be mailed to every active member of the Bar in these districts, and on June 15 an Election Board, to be announced later, will meet in the Executive Offices, count the ballots, certify the election to the Board, and announce the results to the press.
