### *Recommendation of American Bar Committee*

That for the present prohibitive statute there be substituted the Connecticut statute reading as follows: "No person shall be disqualified as a witness in any action, suit or proceeding by reason of his interest in the event of the same as a party or otherwise. In actions, suits or proceedings by or against the representatives of deceased persons, including proceedings for the probate of wills, any statement of the deceased whether oral or written, shall not be excluded as hearsay provided that the by decedent, and that it was in good faith and on decedent's personal knowledge."
