## LAW SCHOOL BANQUET HELD ON FEBRUARY 7th

Vocal selections by Harry Hansen (first year law student) completed an interesting and well-received program.

## APPLICATIONS BEING RECEIVED BY FEDERAL BUREAU OF INVESTIGATION

The Agent in charge of the Seattle office of the Federal Bureau of Investigation has advised me that the Bureau is interested in receiving applications from those qualified for appointments as Special Agents.

Basic qualifications are as follows:

An applicant must be between the ages of 23 and 35; a graduate of a recognized school of law; at least 5' 7" in height; have uncorrected vision of not less than 20/40 in one eye and at least 20/50 in the weaker eye without glasses, and at least 20/20 in each eye corrected; and be in such physical condition that he can be certified for strenuous physical exertion by an examining physician. No applicant can be considered who has been found to be color blind.

Entrance salary for Special Agents is \$3200 per annum.
