Notice is hereby given that the petition of Pierce Lonergan for reinstatement to membership in Washington State Bar Association has been filed and that said petition will come on for hearing before the Board of Governors of Washington State Bar Association at its meeting to be held at 655 Dexter Horton Building, Seattle, Washington, at the hour of 10:00 a.m. on the 13th day of December, 1941.

Mr. Lonergan resigned from membership in Washington State Bar Association on the 26th day of January, 1939, after conviction in the United States Courts upon a charge of violating the mail fraud statutes. His resignation was accepted by the Supreme Court on the 16th day of March, 1939.
