## BAR BRIEFS

Of principal interest to members of the Bar practicing in southwest Washington is the opening of Clark County's new courthouse by the removal of offices from the old courthouse this last fall. Clark County celebrated the dedication of the new courthouse, which was built entirely with local funds and without federal aid, on November 29, 1941, with Governor Langlie present to formally dedicate the building.

Clifford N. Langhorn, President of the Tacoma Bar Association, has appointed a committee of which Bartlett Rummel is chairman to study and recommend revision of the present minimum fee bill.

S. H. Kelleran, graduate of Cornell University, who has practiced in Seattle since 1908, has been appointed counsel of the Washington State Bar Association by the Board of Governors to replace S. M. Brackett, recently deceased.

The Tacoma Bar Association will hold its annual Lincoln Day Banquet Thursday, February 12, in Tacoma, and the State Board of Governors will make that the occasion for holding its monthly meeting in Tacoma on that date.

Judge James P. Dillard, president of the State Bar Association, scheduled an address before the Bremerton Bar Association on January 27, and an address before the Seattle Bar Association at its weekly luncheon on the following day.
