## BAR BRIEFS

Miss Clydene Morris has recently received a letter from Captain Shirley R. Marsh in which all of the members of the Bar will undoubtedly be interested. Capt. Marsh, who is connected with the Civil Affairs Training Center, has spent considerable time under the burning sun of Africa and subsequent to that by way of contrast, shivered in the snow and ice of Southern Italy. We are repeating what Capt. Marsh reports and assume no liability for disagreement with pre-war travel literature. The letter was written from England where the Captain is currently stationed. On a leave of absence he spent some time in London and reports interestingly concerning a parliamentary debate relative to the rights of women to receive equal pay for equal work. He also tells of having listened to Winston Churchill address the House, at the conclusion of which address the Prime Minister demanded and received a vote of confidence. A clipping from a London paper was enclosed wherein the Judge of one of the English courts reprimanded the barristers for hurrying out of chambers every time it appeared that counsel would be required for an indigent prisoner. The Captain remarked that for all its tradition, the English barristers apparently had no greater desire for non-paying clients than their American brethren. In his travels he has met among others, Judge Douglas, Judge Dawson of Bellingham and Carl Quackenbush.
