DISTRIBUTION OF LAWYERS IN WASHINGTON

Many returning veterans who are seeking to establish or re-establish themselves in the practice of law have been interested in ascertaining the relative density of the legal population throughout the state. As an aid to the presentation of a picture of the distribution of lawyers, the Bar Association has prepared the following compilation, which indicates not only the number of active members of the Association and where they are now located, but also the number of lawyers practicing in the same communities during the year 1944.

An inspection of the accompanying list will indicate which sections have gained or lost lawyers during the past two years. It is hoped that this list will be of considerable help to those who are interested in the statistics which it presents.
